No.EDN.69/2010/67.—In pursuance to the powers conferred under first proviso of Section 3 of the Central Educational Institution (Reservation in Admission) Act, 2006 as amended and in pursuance to the existing policy of the State Government to reserve 100% of seats for admission to various technical courses for domiciles of the State of Meghalaya out of which 15% is reserved for open category and 5% is reserved for Scheduled Castes and other Scheduled Tribes, the Governor of Meghalaya is pleased to reserve hundred percent of the home state quota of seats for admission to various technical courses in National Institute of Technology, Meghalaya in accordance with the provisions of the extant State Reservation Policy.

Further, the Government of Meghalaya is pleased to notify that the above State Seats shall be allocated as per the provisions of the State Reservation Policy.

Provided that such persons obtain the minimum qualifying marks in Joint Entrance Examination (Main) to be conducted by the Central Board of School Education, All India Council of Technical Education and/or other regulatory bodies etc.

Provided further that in the event of non-availability of suitable candidates from amongst any category, as prescribed, the reserved seats shall be filled from amongst the other reserved categories.

This order will come into force with immediate effect.

No.EDN.69/2010/68.—In pursuance to the powers conferred under the first proviso of section 3 of the Central Educational Institution (Reservation in Admission) Act, 2006 as amended and in pursuance to the existing policy of the State Government to reserve 100% of seats for admission to various technical courses for domiciles of the State of Meghalaya out of which 80% is reserved for the Major Tribes, 5% is reserved for Scheduled Castes and other Scheduled Tribes and 15% is unreserved, the Governor of Meghalaya is pleased to reserve hundred percent of the home state quota of seats for admission to various technical courses in National Institute of Technology, Meghalaya in consonance with the provisions of the extant State Reservation Policy, 1972.

Further, the Government of Meghalaya is pleased to notify that the above State seats shall be allocated as follows:

1. Open category (from among domiciles of Meghalaya) -15%
2. Khasi and Jaintia Tribe - 40%
3. Garo Tribe - 40%
4. Other Scheduled Tribes and Scheduled Castes - 5%

Provided that such persons obtain the minimum qualifying marks in Joint Entrance Examination (Main) to be conducted by the Central Board of School Education, All India Council of Technical Education and/or other regulatory bodies etc.

Provided further that in the event of non-availability of suitable candidates from amongst any category, as prescribed, the reserved seats shall be filled from amongst the other reserved categories.

Notification No.EDN:69/2010/67 dated Shillong, the 5th June, 2013 is hereby superseded. This order will come into force with immediate effect.
