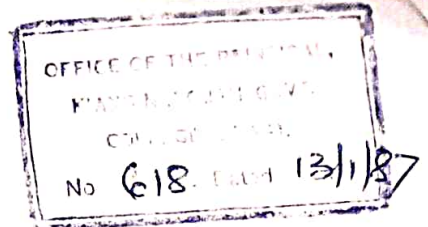





Sub: Renewal of Provisional Affiliation for B.Com.(Hons) course.

Sir,

I am to convey the decision of the 105<sup>th</sup> Academic Council vide Resolution No:AC:105:2020:5:7:(i) held on 10<sup>th</sup> December 2020 which resolved to regret granting of Permanent Affiliation for B.Com.(Hons) course.

The Academic Council further resolved to grant renewal of Provisional Affiliation for B.Com.(Hons) course with retrospective effect for a period of 3 (three) years w.e.f. academic sessions 2018-19 to 2020-21 in continuation to the Affiliation granted vide this office letter No.CDC/A.12/2007/-503 dated 23/9/2016.

The College is required to fulfill the following conditions as laid down by the Inspection Team:

1. The College is to expedite recruitment of - i) Vice-Principal; ii) librarian; and iii) assistant librarian as per the UGC/University guidelines in this regard.
2. The College is to strengthen its Library immediately by-
  - i. Subscribing at least two journals in Commerce from UGC-CARE list that are matching with the current specialisation being offered;
  - ii. Subscribing to periodicals including pink paper as suggested during the visit in order to update the faculties and students with contemporary developments in dynamic subjects like Direct & Indirect Taxes, Accounting Standards, Auditing, Banking and Indian Financial System, etc;
  - iii. Acquiring books for all subjects from variety of authors in general to come up to the requirement of 500 books each specialisation being offered maintaining ratio of 5:1 for Text books and 10:1 for (reference books) (RB-5 under OB-6);
  - iv. Acquiring latest books in dynamic papers such as Accounting Standards (Ind AS), International Financial Reporting Standards (IFRS), Auditing & Assurance Standards, Income Tax, Goods & Services Tax, Business/ Company Laws, etc for both reference as well as text book section;
  - v. Enriching the reference section.
