The vacation of the premises will not be made while a module or training program is in session but only after the completion of such program, be it three-month program or as per number of hours indicated in the NSDC (National Skill Development Corporation) manual.
5. That the **Second Party** shall use the said premises and shared amenities such as computer laboratory, Library and other common spaces for their Skill Training and Educational purposes only;
6. It is specifically agreed that a month of occupancy shall be English Calendar Month, and for all purposes including termination of the occupancy, commences from the 1st day of every month and ends with the last day of the same month;

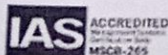

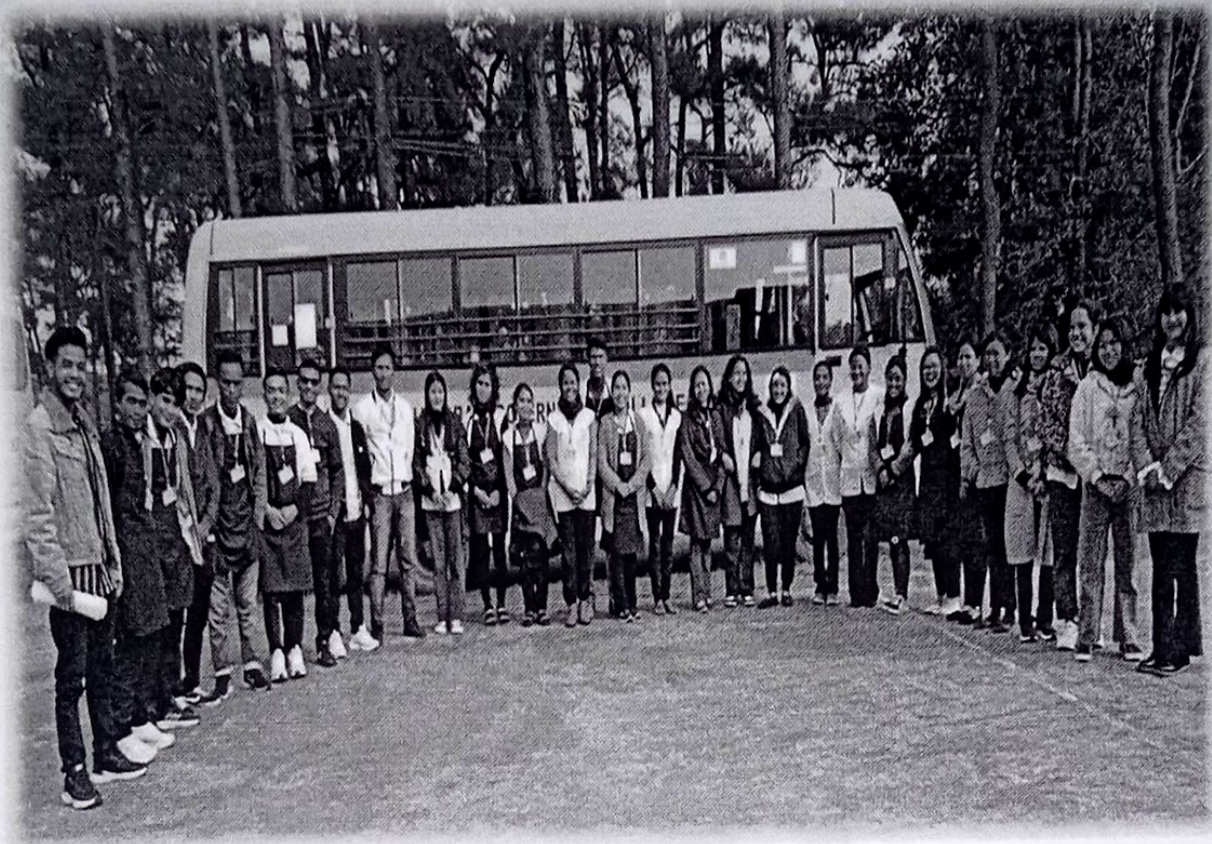

Memorandum of Understanding

This **Deed of Agreement** made and executed at Shillong on this 14/2/2022 day of March, 2022 between:

Kiang Nangbah Govt. College, Jowai
Lad Nartiang hereinafter called the **First Party**

AND

Greta Solutions, All Seasons Building, Nongrimbah, Laitumkhrah, Shillong, Meghalaya- 793003 hereinafter called the **Second Party - Training Provider** (which expression shall, unless repugnant to the context mean and include their heirs, legal representatives and successors-in-interests and assigns) of the other part.

Whereas the **First Party** is the owner of property has agreed to allow the use of 5000 Sq. ft. more or less Open-air Space and 1000 sq ft. more or less Covered area (Comprising of training rooms, Separate male and female toilet and common area) to the **Second Party**. This consent will be applicable so long as training program is being conducted by the second Party with terms and conditions to be reviewed on mutual understanding annually with the support and participation of the First Party on the following **Terms and Conditions**:



NOW THIS DEED WITNESSETH AS FOLLOWS:

1. That the skill training programs will be conducted in collaboration of The Second Party with The First Party
2. That the First Party will take part in certification of trainings conducted by the Second Party.
3. That this Agreement shall be for a period so long as the Skill training of students is in operation and functional.
4. Three-months' notice after the completion of any module of training under Skill India Portal from either side can be intimated for dissolution of this agreement or vacation of premises. The vacation of the premises will not be made while a module or training program is in session but only after the completion of such program, be it three-month program or as per number of hours indicated in the NSDC (National Skill Development Corporation) manual.
5. That the **Second Party** shall use the said premises and shared amenities such as computer laboratory, Library and other common spaces for their Skill Training and Educational purposes only;
6. It is specifically agreed that a month of occupancy shall be English Calendar Month, and for all purposes including termination of the occupancy, commences from the 1st day of every month and ends with the last day of the same month;
7. The **Second Party** hereby covenant to the **First Party** as follows:
 - (a) To keep the premises in good and clean condition at all times during the period of tenancy;
 - (b) At any time during the said term not to carry on or permit any offences on the said premises;
 - (c) Not to assign their interest in the said premises to anyone under this deed nor sublet or part with the possession of the same or any part thereof to anyone;
 - (d) The **Second Party** shall comply with the rules and regulations of the Society /local authorities whatsoever in relation to the demised premises;
 - (e) The eligible students of the college will be given preference prior to admission of others.
8. The above stated period of occupancy can be curtailed by the Second Party with a clear **Notice of 3 Months** in writing to the **First Party**, and the **First Party** shall serve **3 Months' Notice** to the Second Party in case of vacation of the said property;
9. That the **Second Party –Second Party** shall not store any hazardous and offensive articles in the said premises;
10. That after the expiry of the lease/tenancy, the **Second Party** shall handover the pursuant vacant possession of the allotted premises to the **First Party** in the same condition;

12. That the **First Party** shall be at liberty to inspect the allotted premises at any given time with consent in the presence of an authorized representative of the **Second Party**;
13. That the **First Party** shall pay the **Property Tax** and other taxes payable to the local authorities or the Municipal Corporation
14. That the **First Party** and the **Second Party** represent and warrant that they are fully empowered, authorized and competent to make this **Agreement**;
15. In the event of any **dispute** arising under this Agreement, the Courts of West Jaintia Hills shall have the jurisdiction.

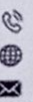
